Whale Trust allocates a percentage of funds raised to donate to local non-profit organizations and graduate students conducting whale research in Hawaii. Grant distributions are determined by a committee comprised of advisory and board members. All grantees are required to submit a final report detailing how grant funds were used within one year of receiving the funds.
